

#### CONDUCTOR The Orchestration Engine

Conductor is the command center of OSS. It assigns digitization and processing jobs to clusters of **Performer Nodes**—independent client workstations working in parallel to speed up batch processing. It also manages scheduling, automation, and task verification across the system.

- Supports massive horizontal scaling by simply adding more nodes.
- Works with input workstations or high-speed document scanners.
- Enables seamless expansion for large enterprise environments.



#### COMPOSER Standards-Based Project Configuration

Composer allows users to define how digital records should be created, based on material type and project scope. It automatically applies NARAcompliant requirements for permanent federal records.

- Build project specifications aligned with federal digitization standards.
- Ensure consistency and quality before digitization begins.



#### VIRTUOSO Batch Verification & Compliance Auditing

Virtuoso processes batches of digitized images and verifies compliance with the specifications created in Composer. It performs deep introspection and produces a detailed **Regulations Audit Report**.

- Confirms compliance with **36 CFR Part 1236, Subpart E**.
- Identifies non-compliant records and provides actionable remediation steps.
- Supports full audit traceability with forensic metadata.

OSS is deployed on-premises in a secure, bespoke configuration tailored to your organization's infrastructure and records workflows. Each deployment includes:

- OSS server and multiple performer nodes
- GoldenThread NXT for image quality assurance
