Virtuoso Desktop provides an inspection of a batch of digitized records for compliance with the mandatory regulations found in the **National Archives and Records Administration's Electronic Code of Federal Regulations (36 CFR Part 1236, Subpart E)**. For each part of these rules, an audit report provides detailed results regarding compliance or non-compliance, including:

- Master file requirements
- Reference targets
- Metadata
- Checksums

The report also generates supporting forensic information. The forensic information demonstrates how the assertions in the report were determined and facilitates independent reproduction of the results for compliance or non-compliance.

*Virtuoso Desktop is installed by users on a single computer and is a software-only solution that does not include any hardware.*

*Virtuoso Desktop is offered in a bundle with GoldenThread NXT. GoldenThread Device/DICE Level Targets offered separately.*
